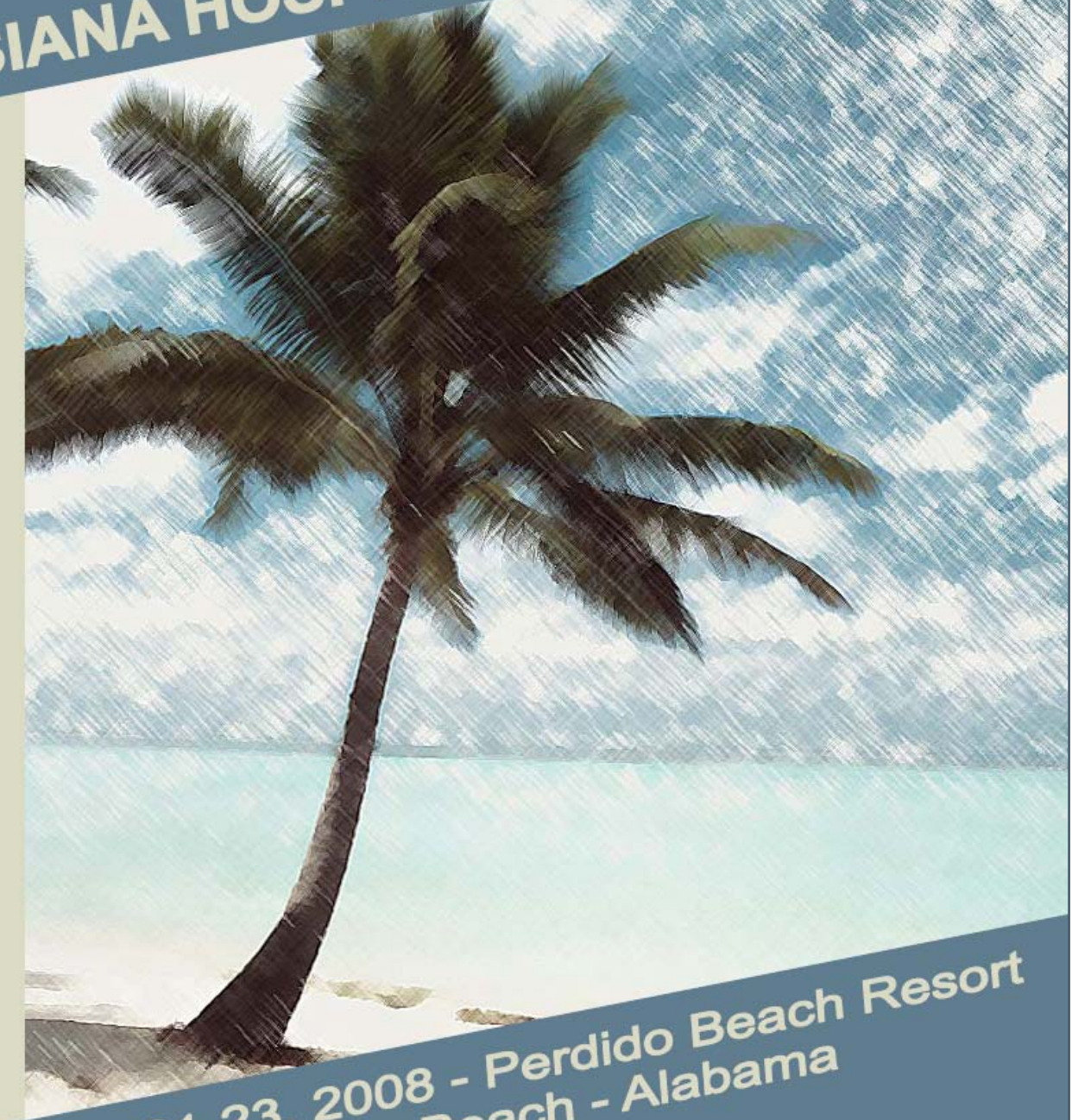

The redesigned Form 990 issued by the IRS has extensive reporting requirements for all nonprofit organizations. In addition to reporting on key financial and operating data, tax-exempt hospitals will be required to report the amount of charity care provided and quantify the benefits to the community. Nonprofit organizations need to begin preparing for this heightened scrutiny by the IRS.
