Capital Area United Way Hosts Annual Meeting

Baton Rouge, LA – (Thursday, March 19) Capital Area United Way honored volunteers and donors, reflected on last year, and elected the 2009 Board of Directors at the 2008 Annual Meeting held at the Varsity Theatre.

Phyllis Coleman Mouton, Chair of the Board, opened the meeting and recalled some of the highlights in 2008. She extended thanks to "our most generous donors –individuals and companies –whose response to the call for help was astounding."

2008 Campaign Chair, Rolfe McCollister, announced that \$11,230,735 was raised during the 2008 annual campaign.

While the 2008 total is lower than the 2007 campaign of \$11,796,578, United Way anticipates that a greater portion of campaign funds will be available for its Member Agencies than was available for allocations last year as United Way has lowered internal expenses and created greater organizational efficiencies.

Karen Profita, President and CEO said she is pleased with the result because 2008 was the year of Hurricanes Gustav and Ike and an economic recession that has affected many.

In addition, the change in 2008 to allocating Member Agency funds on a fiscal year cycle versus calendar year allow for greater accuracy of funding decisions and lower risk of over-allocating and creation of deficit spending.

Incoming Board Chair, Van Mayhall, Jr. announced that United Way will unveil a 3-year strategic plan in the coming months. The plan will serve as the guide for the direction of the organization. Included will be goals with clear deliverables for the areas of focus, impact, administration, finance, and resource and relationship development.

In conjunction with the 3-year strategic plan, Karen Profita announced that the organization will be focusing on four key areas: health, education, basic needs, and income.

During the Annual Meeting, CAUW also presented the "Big Five" awards which recognized individuals, companies, and organizations that made a significant contribution to United Way. The 2008 award recipients announced were:
